- Motion to establish eight (8) scholarships of up to \$500 each to be used for registration and hotel for OA's 2025 World Service Convention
 - O Nothing in PTI Bylaws or PTI Policies prevent using scholarship for hotel, but the application instructions do specify a cap of \$236. The BYLAWS need to be updated because they specify a cap of \$200. Current balance over Prudent Reserve is \$3250. Average monthly donations amount to \$373.
 - O Application requirements (report back with 2-3 paragraphs to PTI meeting- can be anonymous, waived abstinence requirements, attend at least 3 months/continuous group attendance, reside in Pinellas, Pasco or Hernando, attend 2 PTI meetings before and after convention, suggested service at event). Ways and Means Committee will evaluate scholarships.
 - O Member is reimbursed after they send in the receipts and the report.
 - O First come first serve for applicants. If there are additional applicants, the number of scholarships awarded can be revisited.
 - O Applicant will be asked specifically the amount needed up to \$500.
